The Descent of Cleygate Manor

MSS215 / 1

A summary of owners, being the lords of the manor (for more detail please see the following pages)

From 1384 to 1439, lands called Cleygate, within the manor of Henley, were rented by the Crown to various tenants.

From the time of Henry VI (1422-61) up to 1560, the manor of Cleygate was owned by the Crown and leased to various tenants.

22 Jan 1560, Queen Elizabeth sold it to Edward Fynes, Lord Clinton & Saye.

6 Aug 1564, Lord Clinton sold to Christopher Draper, alderman of London, for £1,240.

2 Jan 1565, Christopher Draper sold to William Harding, yeoman of Wanborough, for £1,190.

William Harding died and it descended to his son William, then William junior died and it descended to his sister Mary Harding who married Sir Robert Gorges.

In 1621 Sir Robert and Mary Gorges sold to Sir Thomas White.

In the 1630s Sir Thomas White willed it to his wife's nephew, Robert Woodroffe of Poyle.

It remained in the Woodroffe family for several generations.

In 1779 George Woodroffe died and it descended to his nephew Rev. William Billinghurst.

The Rev William Billinghurst died and it descended to his son William. William Billinghurst changed his name to Woodroffe.

William Woodroffe (formerly Billinghurst) died and it descended to his brother Col George Woodroffe.

In 1854 Col George Woodroffe died and his property descended to his great nephew Henry Chester. The Chesters' Poyle estate was leased to Col James Mangles.

By 1856 the manor of Cleygate was owned by Charles Edward Mangles Esq.

On the 1st of November 1876, Mrs Rose Mangles the widow of Charles, sold to the War Department for £19.800.

The War Department was subsequently renamed the Ministry of Defence, who remain the owners today.

With grateful thanks to Judy Turner formerly of Little Flexford, who went to much trouble to track down the Manor of Cleygate court records and 'rescue' them from the back recesses of a solicitor's office, thus ensuring their safe deposit at the Public Record Office where they are accessible to everyone.

Beware! There is another manor of Cleygate in the county of Surrey. That one is near Thames Ditton, and it was owned in medieval times by Westminster Abbey. Its early court rolls are at Westminster Abbey Library.
